PHOTOGRAPHER RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I, the undersigned, hereby give up all of my rights to bring legal action against or make any claim whatsoever against Mojave Desert Racing, Inc., (MDR) its Officers, Agents, Employees, Servants, Sponsors, Sanctioners, and Company Sanctioners, and the Bureau of Land Management, its Officers, Agents, Employees, Servants, and all other persons, participants or organizations conducting or connected with this event for any property loss and/or damage, or personal injury and/or loss that I may suffer, including crippling injury or death, while I am on the event premises.

I know the risks of danger to myself and my property while I am filming, videoing and/or taking still pictures of the event and while upon the event premises and relying upon my own judgment and ability, assume all risk of loss and take full responsibility for risk of bodily injury, death, and/or property damage due to the negligence of myself or my company or those under my supervision. I hereby agree to reimburse all costs to those persons or organizations connected with this event for damages incurred as a result of my negligence.

I agree that Mojave Desert Racing, Inc., or its assigns, on a nonexclusive basis, may use any pictures, including pictures of any racing equipment and pictures taken at any sanctioned event on Friday and/or Saturday of race weekend, taken by myself or the company I represent or anyone under my supervision, for any purpose and in any media including, but not limited to, television, motion pictures, video production, and for use on the web. I agree that Mojave Desert Racing, Inc., or its assigns, may utilize any still pictures or video, including, but not limited to, MDR racers, racing equipment, volunteers, spectators, etc., that I or the company I represent may have taken and displayed on a company or personal website. Mojave Desert Racing, Inc. may, if they so wish, use these pictures or videos taken by myself or the company I represent or those under my supervision, free of charge for various promotions, advertisements, or for use on a website.

I understand that use of any videos, and still pictures depicting Mojave Desert Racing, Inc., MDR racers, racing equipment, volunteers, spectators, etc. is not prohibited on Friday and/or Saturday of race weekend, provided that this Photographer Release and Waiver of Liability and Indemnity Agreement is signed at each race. All videos and still pictures found to be for sale, whether in magazines, newspapers, websites, etc., without the express permission of Mojave Desert Racing, Inc. and without a Photographer Release and Waiver of Liability and Indemnity Agreement signed and on file with Mojave Desert Racing, Inc. is expressly prohibited.
